First Unitarian Church Annual Congregational Meeting May 20, 2012

- XVII. Meeting is called to order at 12:00 p.m. by our president Dave Wisteich.
- XVIII. It is determined that there is a quorum (see list of members present attached).
- XIX. Invocation is provided by Rev. Wiltshire to begin the meeting.
- XX. Approval of Minutes of Congregational Meetings
 - A. Minutes from Annual Meeting May 22, 2011 were presented. Tom Platt moves to approve the 2011 annual meeting minutes. Bette Asplund seconded the motion. The vote goes unopposed and the motion caries.
 - B. Minutes from Special Meeting February 5, 2012 were presented. Tom Platt moves to approve the February 5, 2012 special meeting minutes. Roger Birdsell seconds the motion. The vote goes unopposed and the motion carries.
- XXI. The minister's report is presented by Rev. Sian Wiltshire. Written report is presented in the annual report.
- XXII. The President's Report is presented by Dave Wisteich, President of the Board of Trustees. Thanks to all the board members and Rev. Wiltshire for all their hard work this past year. A written report is presented in the annual report.
- XXIII. The Treasurer's report is presented by Alice Bentley, Treasurer. The status of the current budget is reviewed and it is determined that as of April 30th, 2010 we are \$10,816.00 in the black for the current fiscal year. Alice reports that as of April 30th we still have 16% of our pledges that have not been received and we have two months to go from this point. The month of February and March both ran a monthly deficit. The full report is presented in the written annual report. Gary Metzler notes that we have made the final arrangements for the Kathy Curtis Memorial fund money. Shortly after the collection of the funds, ½ of the balance collected was given to Step Wise. At this time the other ½ of the balance in the fund will be given to Step Wise and this item will be permanently removed from the back page of the monthly fiscal report.
- XXIV. The 2012-2013 budget is presented. Fern Hamlin asks how many pledges have come in to date and what dollar amount we have as of date. Bob Asplund reports that this information was given to the board two weeks ago at the Board of Trustees meeting but he does not have the numbers today. Dale Gibson explains that he does not feel comfortable passing a budget without knowing how much pledge money we have in for our next fiscal year so far. Melanie Smith Guillaume would like the board or finance committee to give the congregation statistics and numbers so that everyone can compare our stewardship campaigns from year to year.

Dave Wistreich mentions at this time that GSMS gave First Unitarian Church an option for a third year lease. This is only a 1 year option. The rent has increased by \$429.00 per month which is reflected in the proposed budget. Barbara Williams asks if we have looked into others options such as sharing with other spiritual institutions. Anne Mannix answers that the Site

Selection Task Force looked into a room at the Century Center and a Hilton Garden Inn. Both were in the range of \$15,000.00 per year, which is substantially less that we are spending now. Both facilities seemed quite interested in renting to the church. Dave clarifies a point by explaining that GSMS could come to the table next year and not offer us a lease option at all.

Elena Wake asks why we have so much money in line item #990. She explains that the last settled ministry search committee did not spend this much money. Sian explains that the UUA recommends that this amount be budgeted for a settled minister search.

Anne Mannix moves to approve the annual budget as presented. Bill Stevens seconds the motion. The vote passes with one opposition.

XXV. The slate of officers is presented. Fern Hamlin feels we are in violation of Article 7 of our Bylaws by not having a printed slate of officers for the meeting today. Roger Birdsell explains that if we nominate people from the floor today we are not in violation of any bylaw. Roger Birdsell nominates David Mayfield for the office of vice President of the Board of Trustees. David accepts the nomination. Roger Birdsell nominates Gail deSomer for the office of Trustee on the Board of Trustees. Gail accepts the nomination. Roger Birdsell nominates Elizabeth Scarborough for the office of Endowment Committee. Elizabeth accepts the nomination. Bob Asplund nominates Joe Gress for the office of Trustee on the Board of Trustees. Joe accepts the nomination. Elizabeth Scarborough nominates Fern Hamlin for the office of Secretary on the Board of Trustees. Fern accepts the nomination.

After congregational review, Dave Barry suggested a friendly amendment to the written proposed amendment to article V of the by-Laws. Under # 4 Dave would like it to read, "notice to be delivered physically or digitally" instead of "emailed". Dave feels like the word email puts to much constraint on the delivery method. Gary Metzler moves to withdraw this item from the agenda until further info is gathered. Darlene Catello seconds the motion. The vote goes unopposed.

XXIX. The Board of Trustees were recognized for all the work they have done over the past year(s).

- XXX. Other Business
 - Melanie Smith Guillaume moves that beginning with the annual report of may A. 2013, a report be included annually that shows the dollar amount of pledges received in the stewardship campaign by April 30, the percentage of pledge payments received that is already in the operating budget, the percentage of pledge payments received as of the previous fiscal year, the percentage of pledges not paid, the dollar amount of pledges not paid, and all this same information for the previous 4 years. Fern Hamlin seconds the motion. Bob Asplund mentions that he has real concerns about pledge units that take longer to commit. He is not comfortable pressuring people into making a decision quickly if they feel they need more time to decide. Lynn feels we are asking them to decide so that we have clarity and so the congregation knows where we are with our campaign before the annual meeting. Gary Metzler has concerns that this is not the proper place to be voting on this motion. He would like to know who is going to enforce this policy if we vote on it at the annual meeting. He would like to know who would be in charge of making this happen and overseeing how it happens. The vote is taken. 25 in favor, 10 oppose. The vote passes.
 - B. Dale Gibson is interested in what the Site Selection Task Force is doing at this time. Anne Mannix listed off the members of the committee as follows:

Anne explains that the group is continuing to look at vacant land that is privately owned and land that is owned by the city as well as standing structures. The board has authorized the Site Selection committee to consider properties and land up to a 5 mile radius from the city center. The committee will research and disseminate pertinent information to the congregation in a timely manner. Anne will circulate a list of criteria to the congregation so that people who find properties know if it will qualify for further exploration.

First Unitarian Church of South Bend Special Congregational Meeting March 17, 2013

Call to Order

Meeting was called to order at 11:48 a.m. by our president Bob Asplund. It was determined there was a quorum by member signatures (see a list of members present attached).

Presentation of the Motion

Bob Asplund read aloud the motion. Roger Birdsell moves that A negotiating committee made up of members of the Board of Trustees and the Site Selection Committee be authorized to engage in negotiations with the seller of 801 East Washington for the purpose of purchase of said building and that (a) the congregation approves this motion with at least an 80% majority and (b) that the seller either provide evidence of completed professional mold remediation or reduce the price so that this congregation can contract with professionals for this purpose. Bob Cope seconds the motion.

Discussion

Bob Asplund would like to offer an amendment to the motion to state after 80%, "of those in attendance or with proxys." A vote was conducted and the amendment carries unanimously. Pat Taplick mentions that with only around 60 people present to vote, there are quite a few members that may not support this motion. Lynn McDonald proposes an amendment so that the motion will contain a contingency that First Unitarian Church will be able to secure use of the TCU parking lot. A vote was taken with 1 vote in support of the amendment. The amendment does not carry.

Vote: Bob Asplund called the question. Roger Birdsell seconded.

64 votes to pass the motion. 1 no vote.

The vote carries.

"Recognizing the necessity of a change in process, I move that we authorize the Ministerial Search Committee to choose a Contract Minister and negotiate salary for final approval and hire by the Board of Trustees."

Motion was seconded by Marilyn Shaul and approved by voice vote with no nays or abstentions.

Motion to adjourn was made by Kay Azar, seconded by Tama Crisovan, and passed by voice vote.

Meeting adjourned about 7:30.

First Unitarian Church Annual Report Sian Wiltshire Interim Minister May 19, 2013

Can you believe it? Almost two years have come and gone since I arrived as your Interim Minister and what a journey it has been. If you recall, the fall that I arrived, I attended a training in interim ministry and told that there were five tasks of interim ministry. Here is an evaluation of how I think we have done on these five tasks:

The first task is to claim and honor the congregation's past and engaging and acknowledging its griefs and conflicts. We accomplished much of this in the first year, with cottage conversations designed to air our grievances and sorrows with the move and the former minister. We then also celebrated the 60th anniversary of the congregation. Old conflicts sometimes arise, but I also sense that people are learning to be kinder to one another when conflict does arise, that listening is occurring and there is a desire to work through conflict, not to avoid it.

The second task is to recognize the congregation's unique identity and its strengths, needs, and challenges. We tackled this in a discussion at the board retreat this last summer and then also when the congregation looked at the needs of a new minister and a new home during some cottage conversations in the fall. When I arrived I noticed that there was a great deal of self-flagellation around mistakes made by leaders or congregants. South Bend has no more problems than any other small congregation and in fact has many strengths, including the dedication, resilience and creativity of it's congregants and leaders. I believe that the story the congregation tells about itself will determine it's future, so I encourage you to tell a more realistic and loving story!

The third task is to understand the appropriate leadership roles of minister(s), church staff, and lay leaders and navigating the shifts in leadership that may accompany times of transition. We've made some strong progress on this front with new covenants (board), policies (sexual harassment and disruptive person), staff and board job descriptions, and guidelines for financial documentation. These documents serve as strong foundations upon which to built a stable and healthy church. As the church grows, this congregation will need to look at bylaws and policies to help make clear lines of authority while also respecting our democratic polity.

The fourth task is to make appropriate use of District, UUA, and other outside resources. I think First Unitarian is well on its way and there is a shift toward utilizing the resources of the greater association. I think there is still some distrust of some processes and procedures, but I think that there is a greater sense that the UUA is not perfect, but can be quite helpful. For example, I am delighted that when difficulties or new tasks have arisen, that the UUA and the district resources are often thought of in Board Meetings. In addition, for the first time in many years, there are both adults (and delegates!) and youth attending GA this year. This is exciting for everyone and the youth have agreed to share their learning in worship this summer. I have made it a priority to pass along UUA and District training resources and have encouraged the staff to take advantage of them, to the extent that our Director of Religious Education went to District Assembly this year. I believe that there is a greater use of these resources than there were and I encourage the church to continue its outreach. We UUs tend to have a "reinvent the wheel" mentality, but there are so many wonderful inventors out there who had already done the hard work. Why not utilize their brilliance and add our own?

The fifth task is to renew its vision, strengthening its stewardship, preparing for new growth

and new professional leadership, ready to embrace the future with anticipation and zest. When I asked the board at the retreat in August if they felt they were "ready to embrace the future with anticipation and zest" the response I received was "cautiously optimistic." That feels fairly true to the congregation. There is some excitement and some concern – and naturally so. Just remember that you have been through so much together and you will make it through the next few years. Personally, I am very optimistic for your future. There are currently a lot of uncertainties - the new home, the new minister, finances - and yet they all will, by putting your strengths of creativity and resilience to work, come to fruition.

So those are the five tasks that most interim ministers work on over their 1-2 years with the leadership. But there's a secret to accomplishing these five tasks: to never think you are done. I believe that any church's success is relative to how healthily reflective it can be about its strengths and weaknesses. I encourage the board, along with the new minister, and the congregation to continue it's reflection with the creation of a strategic plan and a new vision statement as you launch into your new ministry.

This has been a wonderful year for me with you all. I feel as if I've seen First Unitarian begin to stretch its wings as it prepares to take flight. I hope I've helped with some of that, with everything from teaching classes, like the class on "Filling the Gap" in the fall, to working with leaders and congregations to solve problems, to leading worship. As I spent some time in January and February away from you looking for my new home and visiting other congregations, I came back with a great deal of gratitude for who you are and where you are going. I feel as if here I have made great progress towards being the minister I want to be - I have been loved, accepted, and encouraged. And who could ask for more? Thank you for all that you have given me. I will miss you all so very much. You have accomplished so much in the last two years and I can't wait to see where you are headed in the years to come. You will always be in my thoughts and prayers.

First Unitarian Church President's Annual Report Bob Asplund May 19, 2013

We are in another transitional year. Hopefully we are much closer to completing some of this change. We have issued a contract to a new minister with whom we are anticipating many years of professional leadership. We have made an offer and a counter offer for a building which could give us our own church home. Just the stability of these two items when completed will give us a strong platform for growth in our ministry to ourselves and the community.

But throughout this change process, we have been working and worshiping together, making a difference among ourselves and others. People are still contributing in many ways, some of which you will read about in this annual report. As president this year, I have had the opportunity to work with many of you directly and many others indirectly in board and committee sessions. I want to thank you for giving me this opportunity to serve this fine congregation.

Although the president needs to be there at different times, it really isn't the elected leadership that makes this church what it is. It's all of us who do our parts in different committees and different activities and different relationships. We all set the tone and provide the support for each other. We all do the small and big things together and we all take the risks together. I thank all of you for making this happen. Together we make a difference.

I need to especially thank Rev. Sian for her leadership these past two years. Her wisdom and leadership has been valuable. I also need to thank Carlton who is always there to make things happen with his work and reminders. Thanks also to Heather who is providing leadership for our RE program. And I need to thank the other members of the board who were all willing to say "I'll do that" when different tasks came before us as a group. It has been great working with you.

First Unitarian Church Treasurer's Report Alice T. Bentley May 19, 2013

We set an ambitious budget for Fiscal Year 2012 - 2013, including costs for a search for a new minister and for a piano accompanist and other music. These and other anticipated expenses, such as an increase in rent, gave us a budget of \$157,398. Our cash flow over the year has had a number of ups and downs with some months running in the red, and some in the black. Thanks to the Service Auction, the Holiday Bazaar, and a number of extra gifts, especially in December, and a very generous contribution in the spring, overall the year-to-date budget has been in the black. As of the end of April, our income for the year has been \$128,456 and expenses for the year were \$117,564, leaving us with a net of \$10,892.

So far this year we have done a good job keeping expenses within the budget. However, as usual, we are running behind in pledge income. As of the end of April, we are \$5,000 below the budgeted amount expected at this point in the year. The pledge amount we budgeted was overly optimistic and the actual amount pledged (including "stimulus" payments) was at least \$11,000 less than budgeted. However, if we all continue to pay our pledges for the next two months we might be able to end the year in the black.

At the time I write this, we are still engaged in negotiations on the East Washington building and the Capital Fund Drive has not kicked off. Several members have been making regular contributions towards the new building already. Funds that are actually "in hand" and relatively readily accessible include three separate CDs (total value = \$270,141), a building fund in our Money Market account (\$5,261) and a portion of the Tudor moneys (also in the Money Market account) that have been designated for use on a church building and are being transferred to the Building Fund (\$23,646). The total of these funds is \$299,048.

Proposed Amendment to the By-Laws First Unitarian Church of South Bend May 19, 2013

Key: *italics* indicates addition; strikeout indicates deletion

ARTICLE V Meeting

- 1. There shall be at least one (1) regular church *congregation* meeting during each fiscal year. *The agenda shall include election of officers and trustees, members of the Nominating Committee and members of the Endowment Committee as specified by the By-Laws; budget review and approval; committee reports; and such other business as may be brought before the meeting by a member.* The specific date, time and place of such meeting shall be fixed by the Board of Trustees.
- 2. Special meetings of the church *congregation* may be called by the Board of Trustees. A special meeting shall be called by the President, or in the President's absence, the Vice-President, upon written petition of ten (10) voting members stating the business to be discussed at the meeting. Such petition shall be read into the minutes of such special meetings.
- 3. Notice of the annual meeting shall be given by public announcements from the church pulpit at least ten (10) days prior to such annual meeting; and by one publication in a newspaper published in St. Joseph County, Indiana, or by posting in two public places in the vicinity of the church, which publication or posting shall not be less than ten (10) days prior to such annual meeting.
- 4. Notice of such regular and special meetings other than the annual meeting shall be given by causing a written notice to be mailed to every voting member of the church at least ten (10) days prior to such meeting, and public announcement of such meeting from the church pulpit at least ten (10) days prior to such meeting. A notice contained in a church newsletter mailed to every member at least ten (10) days prior to such meeting shall be a sufficient notice.
- 3. Notice of any church congregation meeting shall be given by public announcements from the church pulpit at least ten (10) days prior to such meeting and by notice to each voting member at least ten (10) days prior to such meeting either through electronic transmission or through

US Postal Service. Additional notice may also be given through writing in the church newsletter.

- 5. 4. The important business items to be transacted at any meeting of the church *congregation* shall be specified in the notice of the meeting.
- 6. 5. 15% of the voting members, or 25 voting members, whichever is smaller, shall constitute a quorum.
- 7. 6. Voting members present at each church *congregation* meeting shall be required to sign a quorum list, which shall be checked by the Secretary against the list of voting members. The records of voting members shall be maintained by the Secretary and brought up to date immediately prior to each church meeting. No action shall be taken at any church meeting until the presiding officer determines that a quorum is present on the basis of such quorum list. Such quorum list shall be made part of the minutes of each church meeting.
- 7. A church member can vote by proxy at any church congregation meeting by giving such proxy to any other church member attending such meeting. Permission to cast such proxy vote shall be granted in writing and signed by both the absent church member and the specified attending church member. Proxies shall be given to the Secretary prior to any action.
- 8. The vote on any matter shall be by secret ballot upon the request of any voting member. The exact vote on any matter upon the request of any voting member shall be recorded in the minutes of the church *congregation* meeting.

- Bridging Ceremony for our graduating high school students

How our kids experienced social justice:

- Pumpkin Decorating Contest to raise money for UNICEF.
- *Guest at Your Table* and Bread Ceremony intergenerational service & collection.

- CASIE Center Stocking Project: collected donations, stuffed 50 stockings & learned about helping children in need from Carolyn Hahn (hosted by Mary Beth Dickey).
- MLK Day Service project for Ronald McDonald House Charities: made fleece blankets for children in hospital, then toured the facility. On-going pop tab collection.
- Standing on the Side of Love: made "Me" paper dolls to celebrate diversity and "welcome necklaces" for visitors to encourage empathy and inclusion.

- Flower Power Fundraiser: We earned \$404 (\$40.40 General Church Fund and \$363.60 Teen Service Project Fund).
- Applied for and received UUA youth group and delegates/chaperons grants for General Assembly to help cover registration fees.

Committee challenges and concerns:

- Recruiting teachers has been very difficult for the last two years. This makes it difficult for the DRE to schedule teachers, impacts the spiritual home for the children and the continuity of the curriculum, and takes away planning time for the DRE and RE committee for special projects.
- Potential reasons discussed: People do not want to miss services; we have a smaller pool of people because of ministerial search committee and building committee obligations; we have fewer families attending (fewer parent volunteers); people feel uncomfortable teaching because they do not know the kids.
- Potential solutions discussed: Changing RE to occur before/after the service; making teaching mandatory for parents of RE students; finding creative solutions for "one-time" teachers thereby eliminating the missing service conflict; familiarizing the congregation with the kids by planned interactions.
- We are concerned about having a dedicated nursery space and on-site storage in the coming year with the changes in the lease agreement.

Committee activities and accomplishments:

- Hired two nursery care providers, Nicole McCormick (Sept.-Oct.) and Anne Mayer (Nov. pres.).
- Parent Orientation Breakfast.

- Papa Murphy's Pizza Fundraiser for General Assembly expenses: (RE \$88.42 and General Church Fund \$9.83).
- Completed itemization of expenditures for more accurate budgeting and spending for the new fiscal year.
- Special thanks to our committed Youth Group Leaders and RE teachers: Ellen Triebold, Greg Young, Lauren Coil-Sherck, and Board of Trustees members, Mary Alice Hardy and Gail deSomer.
- Many thanks to all of our volunteers who made RE and Youth Group successful!

Goals for the next year:

- Continue to find ways to build lasting faith development in students through developing intergenerational relationships.
- Increase our online presence via webpage and Facebook.
- Increase DRE's visible presence in larger church community.
- Streamline the RE check-in & attendance procedures.
- Continue to enhance DRE's skills by attending workshops/seminars relating to Religious Education.

First Unitarian Church Peace & Justice Committee Report Annual Report May 19, 2013

Peace & Justice Committee members and attendees have been actively involved with the local Gun Violence issues this year, showing up at local rallies to support efforts for Gun Background Checks. Dale Gibson has taken the lead on this issue and has been visible to the community on local news interviews. Members also have been interacting with the Center For Peace & Nonviolence, a local inter-denominational organization. Together, we lobbied Mayor Buttegeig to join the "Mayors Against Gun Violence", which he recently joined. P&J will continue to be involved with the Center For Peace & Nonviolence and participate in their agenda.

Our latest effort is to bring "Books To Inmates". We have gathered and distributed paperback books to the St. Joseph County Jail. Dan and Louis Holm have been key to this cause. In April they delivered our first box of books to the jail. Our focus is on getting "secular" material into the hands of inmates, rather than the typical religious reading material. The Inmate Services Director was very pleased to see this category of books, rather than the traditional Christian items. Our longer term plan is to increase donations of books and expand to the Indiana State Prison population.

Last year we had some activity with GLBT agenda, and we ordered and placed a "Welcoming Congregation" Poster in the Lobby of the Church. We have had guests and films at special meetings to cover GLBT agenda, and members as well as outside guests have attended. Hopefully we can expand our efforts with this cause in the future.

We continue to support the local Northeast Neighborhood Food Pantry with food donations from our Church. These donations have increased with time, especially as Sian had announced this program weekly from the pulpit. Hopefully, this announcement will be continued as a routine part of weekly Services!

Finally, I am honored to be selected as a delegate for this years General Assembly meeting in Louisville! I plan to ask for ideas and support from the Congregation in the coming weeks. I have also been active in Youth Group, assisting Ellen Treibold in bi-monthly meetings. My plan was to get Peace & Justice topics into the meetings, but the youth are so active with other projects that we have discussed "bullying" as an issue, not the greater subjects of social discord that I would have liked to talk about. But the YG are a great bunch of kids, and I am happy to be part of their club!
